



## Who can participate?

The previous education requirement for participating in the distance learning programme is the successful completion of a school-leaving qualification. In addition to this, completed training as an educator/teacher or participation in training as an educator or teacher is required to be accepted as a participant on this course. Certification or training as a childminder or childcare worker, a degree in the area of social/special education or childcare or employment at a childcare facility shall also be recognised as meeting the previous education requirement.

The academy recommends at least one year of previous professional experience.

If there are other requirements, in individual cases this shall be reviewed by submitting a certificate of completed training, further training, traineeships or work experience and accepted or rejected by the examination committee of the distance learning academy (Fernakademie).
